Biological Hazard : Human source material. Treat as potentially infectious. - Other information** : This preparation contains a small amount of sodium azide. Sodium azide is harmful to aquatic organisms and can react with copper, lead, brass or solder in plumbing system and form potentially explosive metal azides. Prevent preparation from entering the drain and water intakes in the environment. If preparation enters the drain, flush with large amounts of water to prevent azide build up. Follow proper disposal procedures.
