2.3 Other hazards

Biological Hazard : Human source material. Treat as potentially infectious. Each serum donor unit used in the preparation of this product has been tested by an FDA approved method and found non-reactive for the presence of HbsAg, HCV and antibody to HIV 1/2. 7.1 Precautions for safe handling
