- Special protective actions for fire-fighters** : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training.
- Special protective equipment for fire-fighters** : Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode. - Other information** : This preparation contains a small amount of sodium azide. Sodium azide is harmful to aquatic organisms and can react with copper, lead, brass or solder in plumbing system and form potentially explosive metal azides. Follow proper disposal procedures.
