Description of necessary first aid measures

Eye contact

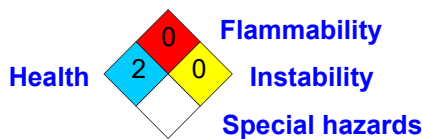
