SECTION 4: First aid measures

- Inhalation** : Remove victim to fresh air and keep at rest in a position comfortable for breathing. 5.3 Advice for firefighters

Special protective actions for fire-fighters : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. This material is harmful to aquatic organisms. 7.1 Precautions for safe handling
