Description of necessary first aid measures

Methods and materials for containment and cleaning up

Store in corrosive resistant container with a resistant inner liner. Separate from alkalis. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers.
