SECTION 6: Accidental release measures

- 6.2 Environmental precautions** : Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
- Other information** : This preparation contains a small amount of sodium azide. Sodium azide is harmful to aquatic organisms and can react with copper, lead, brass or solder in plumbing system and form potentially explosive metal azides. Follow proper disposal procedures.
