Prevent preparation from entering the drain and water intakes in the environment. If preparation enters the drain, flush with large amounts of water to prevent azide build up. Follow proper disposal procedures.

6.3 Methods and materials for containment and cleaning up

Small spill : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

Wash contaminated area with disinfectant.

Large spill : Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. 7.1 Precautions for safe handling
